## 5. ASSUMPTION OF RISK

I acknowledge and accept that the use of the dog bus service and the play field, including off-lead exercise and interaction with other dogs, carries inherent risks. These risks include, but are not limited to, injury, illness, accident, escape, or death, whether caused by another dog, an unforeseen incident, or environmental factors.

## 6. LIABILITY FOR DAMAGE OR INJURY CAUSED BY MY DOG

I accept full legal responsibility for any injury, loss, damage, or expense caused directly or indirectly by my dog to:

Any other dog

Any person

Any vehicle, equipment, or property

I agree to fully indemnify Waggys Wheels against all claims, costs, damages, and legal fees arising from such incidents.

## 7. INJURY, LOSS OR DEATH OF MY DOG

I agree that Waggys Wheels shall not be held liable for any injury, illness, loss, or death of my dog occurring during transport, play, or use of the play field, except where such loss arises solely as a result of proven negligence on the part of Waggys Wheels.

## 8. RELEASE & INDEMNITY

I hereby release, discharge, and hold harmless Waggys Wheels, its owners, employees, contractors, and agents from any and all claims, actions, liabilities, or demands arising out of or in connection with my dog's participation in the dog bus service or use of the play field.

## 9. EMERGENCY VETERINARY TREATMENT

I authorise Waggys Wheels to seek emergency veterinary treatment for my dog where deemed necessary. I understand and agree that all veterinary fees and associated costs shall be my sole responsibility. Reasonable efforts will be made to contact me prior to treatment where practicable.

## 10. RIGHT TO REFUSE OR REMOVE

I understand and agree that Waggys Wheels reserves the right to refuse entry to, or remove, any dog at its sole discretion if the dog is deemed unsafe, unwell, or unsuitable for group transport or play.

## 11. GOVERNING LAW

This agreement shall be governed by and construed in accordance with the laws of England and Wales.
